

Avancer Privacy Policy

Introduction

Avancer Home Appliances "Avancer" (ABN: 75 905 641 841) is committed to protecting your privacy and respects and upholds your rights under the National Privacy Principles contained in the Privacy Act 1988 (Cth) ("Privacy Act"). By using this website, you agree to and consent to the collection, use and disclosure of personal information by Avancer as set out in this policy.

Personal information

Personal information is information or an opinion about an individual whose identity is apparent, or can be reasonably ascertained, from that information or opinion. Personal information we may collect from you includes, without limitation, your name, address, email address, telephone number(s) and date of birth.

Collection

Avancer will collect personal information only by lawful and fair means and not in an unreasonably intrusive way. If it is reasonable and practical to do so, Avancer will only collect personal information about you directly from you. Avancer will not collect personal information unless the information is necessary for our functions and activities.

What does Avancer do with your personal information?

Avancer uses your personal information for the purposes of:

- responding to any inquiries or comments that you submit to us;
- any other purpose you have consented to; and
- any use which is required or authorised by law.

Disclosure of personal information

Avancer may disclose your personal information:

- to third-parties we ordinarily engage for the above purposes;
- any person or entity to whom you have consented to Avancer disclosing your personal information to; and
- any person or entity to whom we are required or authorised to disclose your personal information to in accordance with the law.

Openness

If you believe that Avancer holds personal information about you that is not accurate, complete or up-to-date, then you may request its amendment by Avancer.

Avancer may charge a reasonable fee to cover the charges of retrieving your personal information.

Avancer will take reasonable steps to protect the personal information it holds from misuse and loss and from unauthorised access, modification or disclosure.
